



Official 50/50 Raffle Rules

1. By participating in the OneAZ Community Foundation - 50/50 Raffle ("Raffle"), entrants agree to be bound by: (a) these Official Rules; (b) the decisions of the OneAZ Community Foundation ("The Foundation") with respect thereto; and (c) the Terms of Use, Privacy Policy, and any other such similar agreements and policies promulgated by RallyUp!.com ("RallyUp!"), which is assisting the Foundation with administering the Raffle (together, the "Raffle Terms"). The Raffle Terms shall be binding and final as to all matters related to the Raffle. The Raffle is subject to all applicable federal, state, and local laws, and is void where prohibited.
2. A portion of the proceeds of the Raffle shall be distributed to The Foundation, which shall be utilized by The Foundation in accordance with its standard procedures regarding grants and giving.
3. Raffle participants must be 18 years or older and a legal resident of the State of Arizona to participate. Tickets may not be purchased by or in the name of a minor. By participating in the Raffle and purchasing a ticket(s), such participant agrees they meet all requirements based on the Raffle Terms and Arizona law. All Raffle ticket purchases shall be final, and no refunds or replacements will be issued, unless the Raffle is canceled.
4. Raffle tickets will be made available for purchase online only by The Foundation, and will collect certain personal information in accordance with the Raffle Terms, including but not limited to the participant's name, physical address, and email address. 5. Raffle tickets will be made available for purchase as follows: \$10.00 for 10 tickets; \$25.00 for 50 tickets; \$50.00 for 100 tickets; \$75.00 for 125 tickets; or \$100.00 for 250 tickets, or such other amounts as determined by The Foundation in its sole and absolute discretion.
6. Tickets shall be available from TIME? on 05/15/2025 through TIME? on 06/20/2025 at <https://www.oneazcu.com/about/foundation/>.
7. Upon conclusion of the Raffle, 50% of the total amount of Raffle ticket purchases shall be awarded to the winner of the Raffle as determined by the Foundation in its sole and absolute discretion. The Foundation makes no representation regarding the odds of winning, which depend on many factors including but not limited to the number of Raffle tickets purchased.
8. The Raffle drawing will take place on or about 06/20/2025 online at <https://www.oneazcu.com/about/foundation/>. Raffle tickets will be numbered, and the winning Raffle ticket will be selected by a Random Number Selection System from all Raffle tickets sold, and as such, requests for specific 50/50 numbers are not permitted. One winning entry will be

drawn and shall be announced online at <https://www.oneazcu.com/about/foundation/>. The Raffle is virtual only. The Raffle winner shall be required to present identification or otherwise verify their identity and eligibility to claim the prize, as determined by the Foundation in its sole and absolute discretion. If the winner of the Raffle is unable to verify their identity and eligibility as determined by the Foundation, such funds shall be forfeited by the winner and shall be distributed to The Foundation in its entirety.

9. The Raffle winner will also be notified by email and/or by phone by The Foundation, to the extent valid contact information was provided by the winner. The Raffle winner shall receive any prize funds via ACH transmission or such other method as determined by The Foundation, and as such, each participant agrees that if they win the Raffle, they shall provide the Foundation with information sufficient to enable the Foundation to send the funds to the participant. The Raffle winner must respond with information sufficient to claim the prize within thirty (30) days of the Raffle. If the prize is unclaimed, such funds shall be forfeited by the winner and shall be distributed to The Foundation in its entirety.
10. The following individuals and their immediate families living at the same address are ineligible to participate in the Raffle: the OneAz Community Foundation and OneAZ Credit Union staff, board and supervisory committee members and members of licensed gaming suppliers providing services to this program, in addition to any other applicable limitations as set forth in the Raffle Terms and applicable law.
11. By participating in the Raffle, each participant hereby consents and agrees that if they are the winner of the Raffle, The Foundation is permitted to display the participant's first name and city/state of residence on <https://www.oneazcu.com/about/foundation/>.
12. Raffle winner shall be responsible for any and all applicable federal, state and local income or excise taxes, fees, assessments and like charges associated with the Raffle prize funds that may be awarded by the Foundation. All cash prizes may be subject to applicable income tax withholding. Raffle winnings are taxable income and must be reported as such on income tax returns. The winner may be required to complete and return to The Foundation certain documents, including without limitation IRS Form 5754, W-9 form, and/or other applicable forms and as a condition precedent to receiving the Prize. Raffle ticket purchases are not tax deductible nor considered a donation to The Foundation. The Raffle winner shall be solely responsible for any and all applicable taxes, and the Foundation makes no representation such potential obligations.

By virtue of participating in the Raffle, each Raffle participant hereby releases The Foundation and its respective directors, officers, employees, and agents from any and all liability, claims, causes of action, suits, and demands arising from or related to the Raffle to the fullest extent permitted under the Raffle Terms and applicable law.
14. The Foundation reserves the right, in its sole and absolute discretion, to cancel or suspend this Raffle, in its entirety or in part for any reason. Prizes are not guaranteed.
